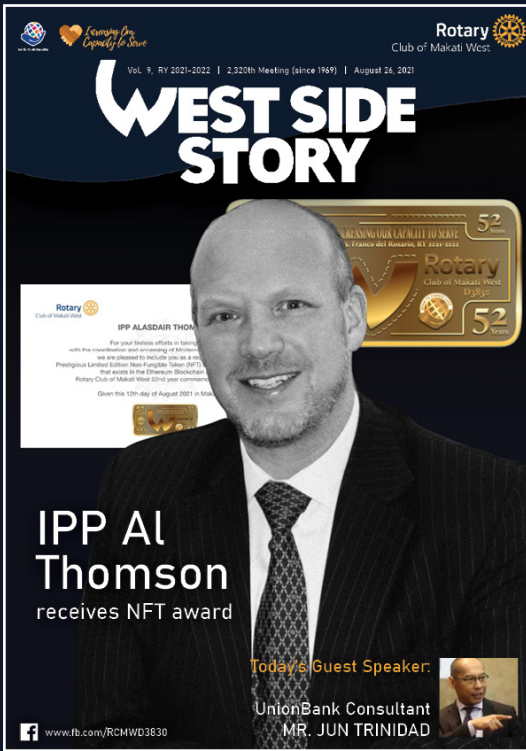

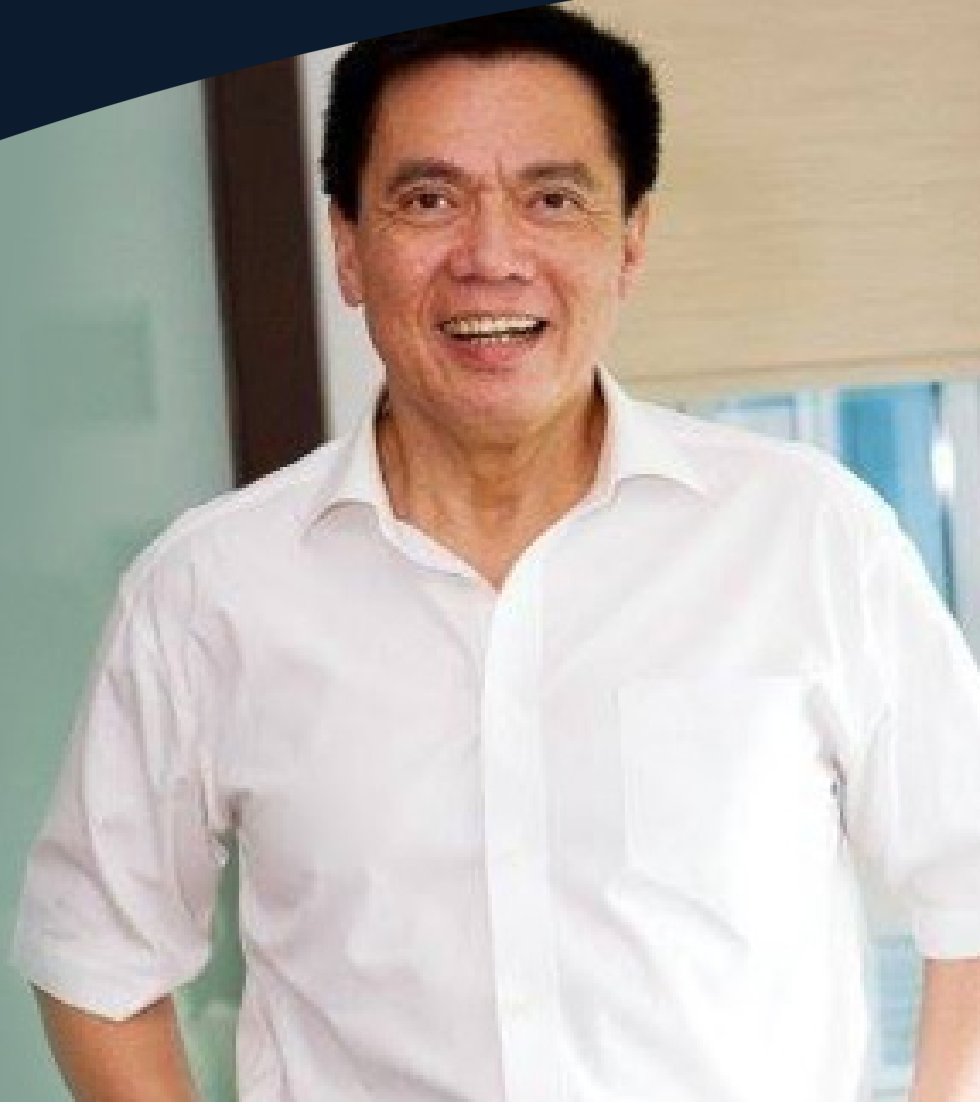

Mr. Jun Trinidad is a well-known scholar in the Economic sector. He earned his economics degree in the University of Santo Tomas, and further pursued his graduate studies in economics in Center for Research and Communications, now University of Asia and Pacific, and University of Manchester.

Mr. Trinidad is an expert in macro analytics or forecasting where he focuses on understanding how these translated to market views on Philippine Peso and also on fixed income debt markets. His career started when he became a researcher in the Economic Forecasting Unit of CRC in the 70s. He is prominent for his position as Senior Economist of Citibank Philippines and Citibank Thailand, until recently, where he served for 17 years.

Mr. Trinidad has current and past consultancy arrangements with asset management/brokerage firms. He has been cited frequently in local (FMAP) and foreign (e.g., the Asset) market surveys on economic research and strategy. He currently serves as Market Strategy Consultant for UnionBank.



PRESIDENT'S MESSAGE

It's the People, Stupid!

The above title was derived from "it's the economy, stupid!" used by the strategist of Bill Clinton during the 1992 presidential campaign to make the point that all the nation was concerned about in an election was the economy.

My theory is a company whose competitive advantage is built around the right people is likely to be among the leaders of their industry. When we try to analyze the root cause of many company problems, we might have come to the conclusion that "it's the people, stupid!" The biggest problem is not acting when we need to make a people change.

A company with a predominance of wrong people takes a human toll. As if the demoralization caused by wrong people is not bad enough, right people in many cases carry the load of the wrong people who don't carry their weight. **The single most harmful thing in a company is the presence of wrong people at senior management levels.**

To counter the existence of wrong people in a company, the company president must relentlessly and unfailingly, at every opportunity, speak about attaching a heavy weight on people management in everyone's job performance plan and managers who take action on the wrong people are the only ones considered for bonus and promotion.

How to Avoid Making a Hiring Mistake

At one point or another, we’ve all made hiring mistakes. “Are all talented people, right people?” The answer is NO! Talented people are not necessarily the right people if their hiring was not based on the values, work ethic, character and personality of the job candidate. Establishing the candidate’s fit with the culture of the company is a must before considering the skills, knowledge and experience. When in doubt, don’t hire!

Is the Company a Good Fit with the Job Candidate?

How does a job seeker choose one company over another? Job candidates are attracted to firms (even smaller ones) that appear to provide them with a higher level of satisfaction in their desire for meaning, excitement, flexibility, impact, and reward.

Two “Musts” to Keeping the Right People

Must #1. A red flag mechanism to detect employee unhappiness. What is the biggest cause of employee unhappiness? Surprisingly, it is not financial. Rather, it is caused by the lack of recognition for employees’ ideas, performance and contributions.

Must #2. A strong sense of belonging to a special place of work. For example, if the company practices a mentoring system, an employee will find it harder to quit if that employee has regular meetings with his mentor.

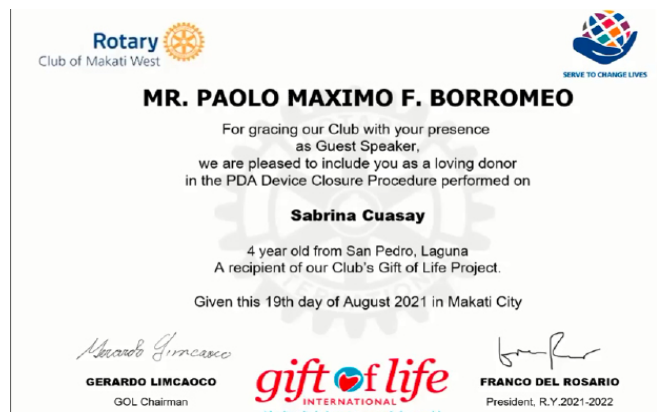

This is the subject of Proclamation No. 1041 signed by former President Fidel V. Ramos on July 15, 1997.

The celebration coincides with the birth month of the late President Manuel L. Quezon, known as the father of the Philippine national language, who was born on Aug. 19, 1878. In a speech delivered on December 30th 1937, from the Malacanan Palace President Quezon announced the creation of a National Language.

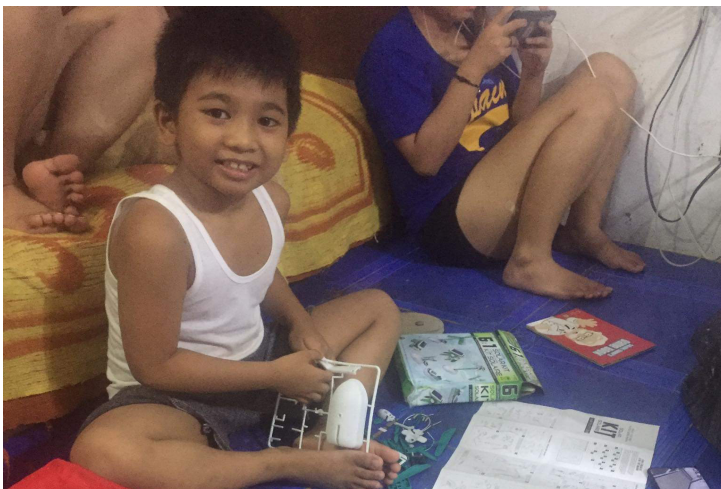

1. WHY HAS THE CLUB FORMED HOME CLUSTERS?

During the pandemic it's been difficult to fellowship with one another. The regular weekly meeting has very limited participation to just a few, namely, the invocator, introducer, moderator and members that ask questions mostly from just a few from the guest speaker.

To make up for the lack of face-to-face fellowship, eight home clusters were established consisting of about a dozen members that live in close proximity to each other. The home cluster meeting attended by a small of group of members provides more members the opportunities to share with one another.

2. WHY ARE HOME CLUSTERS ORGANIZED GEOGRAPHICALLY?

Clusters are geographically organized so that when face-to-face small gatherings are eventually allowed and members become increasingly comfortable to fellowship, home clusters will find it easy to get together if they live close by. For the foreseeable future, home cluster meetings will be limited to mostly zoom meetings.

3. WHAT'S THE PURPOSE OF THE HOME CLUSTER?

A home cluster provides a platform to find out current news about members so they can be recognized. The cluster may organize activities as a group. Likewise, home clusters and participate in a friendly competition with other clusters to vie to be the home cluster with best attendance in regular weekly meetings or the home cluster can vie to be the home cluster with the most Non- Fungible Tokens. Home clusters are also able to celebrate the success of cluster members and celebrate the success of the cluster over some beer and wine.

4. HOW OFTEN WILL HOME CLUSTERS MEET?

The frequency of home cluster meetings is to be determined by the home cluster members. To reap the benefits of the home cluster, a minimum of quarterly home cluster meetings is encouraged.
